AN ORDINANCE

ANNEXING TO THE DOROUGH OF WEST KITTANNING, ARMSTRONG COUNTY, PENNSYLVANIA, A CERTAIN TERRITORY IN THE TOWN-SHIP OF EAST FRANKLIN, ARMSTRONG COUNTY, PENNSYLVANIA, THE SAID TERRITORY BEING ADJAGENT TO THE SAID BOROUGH OF WEST KITTANNING.

WHEREAS, there has been presented to the Town Council of the Borough of West Kittanning a petition signed by a majority in number of all of the freeholders of the territory hereinafter described requesting the annexing of the said tract of land to the Borough of West Kittanning, the said petition describing the said tract of land as hereinafter set forth:

ORDAINS AS FOLLOWS:--

Section 1. That the land described in the said petition of free-holders now situate in the Township of East Franklin, Arastrong County,

Pennsylvania, adjacent to the Borough of West Kittanning as hereinafter bounded and described be and the same is hereby annexed to the Borough of West Kittanning. The said tract of land annexed is hereby bounded and described as follows, to-wit:--

ALL that certain piece, parcel, or tract of land situate in the Township of East Franklin, County of Armstrong and State of Pennsylvania, bounded and described as follows, to-wit:--

Beginning at an iron pin on the southeast corner of First Avenue and Bluff Street in West Kittanning Borough, said iron pin being the extreme southeast corner of the said West Kittanning Borough; thence along the eastern line of Bluff Street, said line being the eastern line of said West Kittanning Borough, N 32° 02' W 1303.30 feet to a concrete monument on the western right-of-way line of the Pittsburg and Shawmut Railroad; thence along said Railroad right-of-way line the following courses and distances: 5 41° 20' E 2h7.4 feet to a point; thence S 32° 02' E 708.0 feet to a concrete monument; thence S 28° 08' E 398.94 feet to an iron pin on the northern right-of-way line of Pennsylvania State Highway Route 122; thence along said right-of-way line the following courses and distances: S 09° 00' E 82.38 feet to a point on the P.C. of a curve to the right having a radius of 982.14 feet; thence by said curve in a

5 00° 54' E 53.23 feet to a point on the P.C. of a curve to the right having a radius of 894.37 feet; thence by said curve in a southwesterly direction 491.71 feet to a point; thence S 59° 24' E 20.00 feet to a point; thence by a curve to the right having a radius of 914.37 feet in a southwesterly direction 228.69 feet to a point; thence leaving said northern right-of-way line and crossing State Highway Route 422 at Sta. 1942463.89 S 44° 09' E 70.00 feet to a point on the southwest corner of Lot No. 125 in the "Kittanning Highlands" Plan of Lots, Sub-Division No. 2; thence along the boundary line between said Lot No. 125 and Lot No. 126 in said Lot Plan S 55° 03' E 205.43 feet to a point; thence along lands of David E. Gulick S 53° 00' W 53.9 feet to a point; thence crossing an abandoned road and the right-of-way of the West Kittanning Water Co. S 69° 08' E 105.52 feet to an iron pin on line of Lot No. 130 in the "Kittanning Highlands" Plan of Lots, Sub-Division No. 3; thence along the south side of said abandoned road S. 74° 001 E 80.00 feet to an iron ping thence again along same lands S 58° 272' E 64.49 feet to an iron pin; thence along lands of the West Mohawk Mining Co. S Ol° 502 E 148.0 feet more or less to the East Franklin, North Buffalo Township division line; thence along said Township line and through Kittanning Highlands Plan of Lots, Sub-Division No. 3, N 88° 152 W 1760.0 feet more or less to a point on the center line of Pennsylvania State Highway Route 03134, Spur "5" at approximately Sta. 4449; thence along the center line of said road and crossing Pennsylvania State Highway Route 422 at Sta. 1927+81.45 N 06° 35' E 416.86 feet more or less to a point on the northern right-of-way line of said State Highway Route 422; thence along said northern right-of-way line the following courses and distances: N 46° 20' W 151.22 feet to a point; thence S 43° 40' W 10.0 feet to a point; thence N 46° 20' W 612.68 feet to a point on the southern line of First Avenue in West Kittanning Berough, the present borough line; thence leaving said highway rightof-way along the southern line of said First Avenue N 77° 43' E 865.25 fest to an iron pin on the northwest corner of the "Veteran's Memorial Athletic Field"; thence along said Athletic Field and said present borough line 5 01° 50% E 333.73 feet to an iron pin on the northeast corner of Arthur Street and Residential Avenue in the "Kittanning Highlands" Plan of Lots Sub-Division No. 1; thence again along said lands and the present borough line N 88° 092' E 553.01

Section 2. That after the effective date of this ordinance, it is directed that under the provisions of "The Borough Cod" that a certified copy of this ordinance together with the description and a plot showing the courses and distances of the boundaries of the Borough of West Kittanning before and after the said annexation be filed in the Court of Quarter Sessions of Armstrong County, Pennsylvania, and that a notice of such filing be filed in the Office of the County Board of Elections of Armstrong County.

Section 3. All ordinances or parts thereof of the Borough of West Kittanning inconsistent with the provisions hereof are hereby repealed.
