AN ORDINANCE.

Annexing to the Borough of West Kittanning, Armstrong County, Pennsylvania, a certain section or portion of East Franklin Township, in said County and State, adjacent to the said Borough, as hereinafter described.

WHEREAS, by a certain indenture dated the first day of October, 1946, recorded in Armstrong County Deed Book Volume 333 page 325, the West Kittanning Fire Department became the owner of a certain parcel or tract of land situate in East Franklin Township, Armstrong County, Pennsylvania, adjacent to the Borough of West Kittanning; the said tract of land being hereinafter more particularly described; and

WHEREAS, the said West Kittanning Fire Department, being sole owner of said tract of land, and holding fee simple fitle thereto, presented to the Town Council of the Borough of West Kittanning its petition that the said tract of land, known as the "West Kittanning Athletic Field", should be annexed to and become a part of said Borough of West Kittanning, which petition was duly accepted and favorably acted upon by the said Town Council of West Kittanning Borough.

THEREFORE, the Town Council of West Kittanning Borough ordains as follows;-

Section 1. That a certain tract of land now situate in East Franklin Township, Armstrong County, Pa., and known as the "West Kittanning Athletic Field", as hereinafter more particularly described, be and the same is hereby annexed to and incorporated into the limits of the said Borough of West Kittanning the said tract of land is bounded and described as follows:

BEGINNING at a peg on the southern borough line of West Kittanning Borough at the southeast corner of Arthur Street and First Avenue; thence along said Borough line north 77 degrees 43 minutes east 562.33 feet to a peg on the southwest corner of said First Avenue and a 50 foot alley; thence along the west side of said alley south 10 50½! East 435.66 feet to a peg at the southwest corner of said alley and Residential Avenue; thence along the north side of Residential Avenue south 880 09½! west 553.01 feet to a peg on the northwest corner of said Residential Avenue and aforesaid Arthur Street; thence along the east side of Arthur Street north 10 50½! west 333.73 feet to the place of beginning. Containing 4.8838 acres, more or less.

Subject, however, to the reservation of coal and mining rights, with other restrictions and conditions, as contained in the deed to West Kittanning Fire Department, above mentioned.

Section 2. That, after the effective date of this Ordinance, the Borough Solicitor is hereby authorized and directed to file, in the Court of Quarter Sessions and in the Office of the County Commissioners (constituting a Board of Election), a certified copy of this ordinance, and a description and plot of the said Borough and said annexation and all other necessary or required papers.

Section 3. All ordinances or parts thereof inconsistent herewith are hereby repealed.
