

BOROUGH OF WEST KITTANNING  
ARMSTRONG COUNTY, PENNSYLVANIA  
AMENDED ORDINANCE # 83-4

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of West Kittanning and it is hereby ordained and enacted by authority of the same as follows:

WHEREAS, on October 5, 1981, after being duly authorized, Ordinance # 81-2 was enacted which directed and required the connection of all occupied buildings with the public sanitary sewage and the method and procedure for the subject connection.

WHEREAS, construction of the subject connections may require the use of a backhoe or some similar machine which may directly or indirectly utilize the Borough street system and possibly adversely affect same.

SECTION 14. In addition to the requirements as set forth in Section 6, no person, firm or corporation shall make or cause to be made any connection with any of the subject public sanitary sewage unless he has given the Mayor or such other designated official at least twenty-four (24) hours notice of the time when such connection shall be made in order that the Mayor or such other designated official can be present to inspect the road surface of any Borough street that may be directly or indirectly

affected by such construction.

SECTION 15. After said connection has been completed, the subject person, firm or corporation shall notify the Mayor or such other designated official of the completion of the connection.

SECTION 16. Upon receiving notification of the completion of the connection, the Mayor or such other designated official shall immediately inspect any affected road surface for any damage directly or indirectly related to the connection.

SECTION 17. The person, firm or corporation making or causing to be made the connection shall be immediately notified in writing of any damage to the road or street surface and shall be responsible at the option of the Borough to repair such damaged portion within five (5) business days from the date of said notice or be assessed and assume responsibility for the reasonable costs of repair in order to return the Borough street to its original condition as it existed on the commencement of the connection construction.

SECTION 18. Any person, firm or corporation making or causing to be made any connection shall maintain a liability insurance policy with a proper company in an amount of \$5,000.

SECTION 19. A certificate of insurance shall be furnished to the Mayor or other designated official incident to the notification

as required by Section 14 as herein set forth.


SECTION 20. Except as inconsistent with this Amendment, all sections and provisions of Ordinance # 81-2 to remain in full force and effect.
