

ORDINANCE NO. PAGE 33 1958

AN ORDINANCE authorizing and directing the paving of North Crescent Drive in the Borough of West Kittanning, starting at the intersection of North Crescent Drive and Harrison Street, to the intersection of North Crescent Drive and Arthur Street, a distance of 800 feet, more or less, and maintaining a uniform width of 18 feet, and establishing a grade therefor.

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of West Kittanning, and it is hereby ORDAINED AND ENACTED by authority of the same

Section 1: That the Borough of West Kittanning, its servants, agents and employees, are hereby authorized and empowered to improve, grade, curb and pave that portion of North Crescent Drive stated in the caption of this Ordinance, with I-D-2 Bituminous Material, with an 8-inch crushed aggregate base course, said material to meet the Pennsylvania State Highway specifications for said material.

Section 2: That the said material is to be furnished and laid by a contractor in accordance with conditions and specifications contained in an advertisement or invitation for sealed bids to be published according to law by the Borough of West Kittanning.

Section 3. Whatever curbing, drains and/or guttering are necessary in the opinion of the Borough Engineer shall be likewise constructed.

Section 4. That the aforesaid improvements, paving, curbing and grading shall be under the direction and supervision of the Borough Engineer and the Borough Street Commissioner.

Section 5. The grade for said street shall be at it now exists.

Section 6: The costs and expenses of the entire work hereby authorized shall be paid by the Borough of West Kittanning and the owners of the real estate abutting or bounding on said street in accordance with Section 1712 of the Borough Code, as amended. One-third of said costs and expenses shall be paid by the Borough, and the same is hereby appropriated therefor out of the funds now or hereafter in the Treasury, and two-thirds of said costs and expenses shall be paid by the owners of real estate bounding or abutting on said street, and the same is hereby assessed according to the foot front rule, and the assessments appropriated therefor.
