ORDINANCE NO.: 2015-1

AN ORDINANCE OF THE BOROUGH OF WEST KITTANNING, ARMSTRONG COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NUMBER 2014-1, TITLED AMENDMENT TO ORDINANCE NO. 71 OPEN BURNING

WHEREAS, Borough Council enacted Ordinance No. 2014-1, known as the Amendment to Ordinance No. 71 Open Burning (the "Ordinance"), in public session after notice and advertisement, on September 8, 2014, for the purpose of promoting public health and safety, and regulating pollution and fire hazards in the Borough.

WHEREAS, in response to citizen and council comments, the Borough Council has decided to amend the Ordinance, which the Borough Council has determined is in furtherance of the above purposes.

IT IS HEREBY ENACTED AND ORDAINED by the Borough Council in and for the Borough of West Kittanning, Armstrong County, Pennsylvania, that Ordinance No. 2014-1 shall be amended as follows:

- I. Section 71-2 (C) Restrictions is amended as follows:

Burning, as defined by this Ordinance, shall only be permitted as follows:

Monday-Thursday	6:00 P.M. – 12:00 A.M.
Friday-Saturday	12:00 P.M. – 2:00 A.M.
Sunday	12:00 P.M. – 12:00 A.M.

Under no circumstances, except as listed below, shall burning, as defined herein, be permitted Monday-Thursday between the hours of 12:00 A.M. and 6:00 P.M., Friday-Saturday between the hours of 2:00 A.M. and 12:00 P.M. and Sunday between the hours of 12:00 A.M. and 12:00 P.M.

Notwithstanding the above time restrictions, burning shall be permitted on the holidays of Memorial Day, July 4th and Labor Day from 12:00 P.M. – 2:00 A.M. Fires allowed to burn or smolder after 3:00 A.M. shall be in violation of this Ordinance, and all those persons or entities causing such fires shall be prosecuted under the guidelines of this Ordinance.

- II. Except as amended hereby, Ordinance No. 2014-1 remains in full force and effect. The amendment described above shall become effective immediately upon passage.
